

## Export certificates to countries outside the EU

Official veterinarians will be at the show venue issuing export certificates as follows:

- Thursday, August 7, 2025 9 AM - 4 PM and
- Friday, August 8, 2025 9 AM - 4 PM

They can be found in Hall 6, Stand 6F23. During the day, a maximum of 50 export certificates can be written. Note! If an export certificate cannot be made on Thursday or Friday, the dog owner must book an appointment for the export inspection directly at the official veterinarian's office, see more below.

The price for issuing one export certificate is 100 euros. Card payments only.

There are two export inspection points: one with a queue principle and the other with an appointment/queue depending on the situation. An appointment can only be made on site, starting on Thursday, August 7, 2025 at 9 AM.

When arriving for the export inspection, the dog owner must have an export certificate form with him/her, filled in with the dog's and owner's information in clear handwriting. If there is no country-specific form for the destination country, you can find the export inspection form attached.

**The dog owner is responsible for clarifying and fulfilling export requirements.** The owner must have all the documents required, including veterinary certificates for possible parasite treatments, for example). It is not possible to medicate or vaccinate dogs on site. The appointments last 15 minutes, during which time the dog is examined and a certificate form is filled out. If the necessary information cannot be clarified within this time or all requirements are not in order, the certificate will not be issued and the dog owner must book a new appointment with the official veterinarian for the following week.

If the dog owner is unable to come to the export inspection on Thursday 7 August 2025 or Friday 8 August 2025 between 9 AM and 4 PM, he/she must make an appointment by contacting the official veterinarians and going to their offices in Kalasatama for the export inspection: [kymp.elaintenvienti@hel.fi](mailto:kymp.elaintenvienti@hel.fi) Official veterinarians are open during office hours on weekdays.
